M.Pharm and B.Pharm programmes

(Session 2017)

On-Line Applications are invited from eligible candidates for admission to M.Pharm and 4-Years B.Pharm Programmes for the academic session 2017 at Main Campus, University of Kashmir. Admission to the courses shall be governed by the Admission policy/PG Prospectus-2017 available on University website and relevant statutes.

i) Important dates:

Submission of On-Line Forms	From 14-08-2017
Last date of submission of On-Line/Hard copy of Application Forms	23-08-2017

ii) Eligibility:

a) M.Pharm.

Should have passed, Bachelor of Pharmacy (B.Pharm.) from the University of Kashmir or any other Institute recognized by UGC/AICTE with at least 55% marks in aggregate for Open Merit and 50% marks for reserved categories,

b) B. Pharm

10+2 (Biology background) with 50% marks for Open Merit and 45% for Reserved category.

iii) Admission Criteria:

a) M.Pharm.

Candidates shall be admitted to various branches of M.Pharm. on the basis of merit prepared on VALID GPAT percentile score (2017) and shall have preference in admission.

The NON-GPAT eligible candidates can also submit Application Form for admission to the course. However, if the numbers of GPAT qualified candidates are less than the intake capacity, the University will conduct the entrance tests for them. The syllabus for the entrance test shall be strictly based on B.Pharm syllabus of this University.

Further the admission of NON-GPAT candidates to a particular specialization will depend on the availability of seats in the respective specialization after filling up of the seats by the GPAT qualified candidates.

b) B. Pharm

The admission will be made on the basis of Entrance Test comprising of Objective Type Questions, to be conducted by the University.

iv) Submission of On-Line/Hard Copy of Application Form:

The candidates are advised to follow the below steps for filling their On-Line Application Forms.

Step-1: Visit <http://www.kashmiruniversity.net> or www.kashmiruniversity.ac.in and click on Link **Admissions 2017**. Read Important Instructions for Registration and Submission of Form carefully before proceeding further.

Step-2: Candidate need to register him/herself before submitting the Online Application Form. For Registration with the System Click on the Register as Student line. Remember the Username and Password for future reference.

Step-3: After successful Registration, login into the system for submitting On-line Application Form. Enter your Registration No. and Click Search.

Step-4: Select the desired Programme and Upload your latest passport size Photograph and specimen signature.

Step-5: Preview the Form displayed on the screen. If details are correct, click on Submit. If there is any variation click on Previous button, make corrections and then Submit. Get a printout of the Form and note the Form No. for future reference.

Step-6: Deposit the Application Fee of Rs. 500/- plus processing fee of Rs. 250/- i.e. 750/- (for M.Pharm Programme GPAT Qualified) (for B.Pharm and M.Pharm (Non-GPAT Qualified) Programmes candidates must have to deposit Application Fee of Rs. 500/- plus Entrance Test Fee of Rs. 500/- which makes total to Rs. 1000/-) (plus Rs. 10/- Bank charges) through Online mode or against the Bank Pay-in-Slip generated with the Application Form, in any of the branches of the J&K Bank Ltd.

v) Submission of downloaded Application Forms (Hard copy):

The candidates after submitting their On-Line Application Forms must submit the downloaded Form (hard copy) with the following documents in the **Department of Pharmaceutical Science University Campus, Hazratbal** and obtain a receipt for record.

- i) Marks Certificate of the qualifying examinations;
- ii) Copy of latest VALID GPAT percentile score Card (2017), if applicable;
- iii) State Subject Certificate;
- iv) Receipt of fee deposited in J&K Bank (University Copy);
- v) Reserved Category Certificate (if claiming admission under Reserved Category)

vi) Additional information:

- The candidates must check the status of their application after five days. In case, acceptance of Form is not uploaded, the candidate should contact the office of the respective Departments.
